We have received your Vote-by-Mail ballot for the March 3, 2020 Consolidated Presidential Primary Election; however, we have determined that the signature you provided on your Vote-by-Mail ballot identification envelope does not match the signature(s) on file in your voter record. Enclosed is a Signature Verification Statement to complete, sign, and return to us. A valid signature is required to process your Vote-by-Mail ballot. A postage paid envelope is enclosed for returning your statement.

FAILURE TO FOLLOW THESE INSTRUCTIONS MAY CAUSE YOUR BALLOT NOT TO COUNT.**

1. We have determined that the signature you provided on your Vote-by-Mail ballot identification envelope does not match the signature(s) on file in your voter record. In order to ensure that your Vote-by-Mail ballot will be counted, a Signature Verification Statement must be completed and returned as soon as possible.
2. Your completed Statement must be received by the Registrar of Voters **no later than 5:00 p.m. on March 31, 2020**, two days prior to certification of the election.
3. You must sign your name where specified on the Statement (Voter's Signature) and include your address.
4. Place your completed Statement into the enclosed postage paid envelope. Mail, deliver, or have the completed Statement delivered to the Registrar of Voters' office at 2720 Gateway Drive, Riverside, CA 92507.
5. If you do not wish to send your completed Statement by mail or have it delivered, you may submit your completed Statement by email at rovweb@rivco.org or facsimile transmission at **(951) 486-7272**, or submit your completed Statement to a polling place within the county or a ballot drop-off box before the close of the polls on Election Day. A 24/7 secure drop box is also available at the Registrar of Voters' office.
