Candidate filing opens Monday for Nov. 6 general election

Anyone interested in running for offices on the Nov. 6 general election ballot may take out candidate filing papers beginning Monday (July 16). Papers must be filed by 5 p.m. on Aug. 10. If an incumbent fails to file, the deadline for that office will be extended to 5 p.m. on Aug. 15 for everyone except the incumbent.
