DEAR PARENTS/STUDENTS,

Since its inception, the Student Poll Worker Program in Riverside County has provided thousands of students throughout the county with an opportunity to participate in the democratic process at its most fundamental level, the polling place. State law allows high school students age 16 years or older with a good academic standing, **2.5 GPA**, a legal permanent resident or a citizen of the U.S., on or before Election Day, to serve as a Student Poll Worker. These students work alongside their adult Election Officer counterparts, putting in the same hours, receiving the same compensation, attending the same training, and performing the same functions.

All students participating in the program are **required** to attend a 2.5 hour training session prior to Election Day at convenient training locations throughout the county. Students will serve with 3 or 4 other members of an election board. The students are expected to be at the polling place on Election Day at 6:15 a.m. and may not be released until approximately 9:00 p.m. after the polls close. Students are responsible for providing their own transportation to training and to their assigned polling place. While we cannot promise that your student will work within close proximity to their school or home, we will try to place your student as nearby as possible. Students are given compensation the same as other Student Poll Workers, \$90.00 for Election Day and \$20.00 for attending a 2.5 hour training session*. Compensation checks are issued 8 weeks after the election.

The Registrar of Voters has a great demand for Student Poll Workers with bilingual skills in **Spanish, Tagalog, Korean, Chinese (Cantonese/Mandarin) and Vietnamese** languages. Bilingual Student Poll Workers assist limited English proficient voters at the polls to facilitate effective participation in elections.

In order for your student to be considered for this program, students must complete the attached Nomination Form, meet the requirements and deadline, and obtain signatures from their parents and nominating **Civics, Social Studies** or **Language** teacher.
