Since its inception, the Student Election Officer Program in Riverside County has provided thousands of students throughout the county with an opportunity to participate in the democratic process at its most fundamental level, the vote center. State law allows high school students age 16 years or older with a good academic standing, **2.5 GPA**, a legal permanent resident or a citizen of the U.S., on or before Election Day, to serve as a Student Election Officer. These students work alongside their adult Election Officer counterparts, putting in the same hours, receiving the same compensation, attending the same training, and performing the same functions.

All students participating in the program are **required** to attend a three hour training session prior to Election Day at convenient training locations throughout Riverside County. Students will serve with 8 other members of a vote center. The students are expected to be at the vote center on Saturday, November 2, 2024, Sunday, November 3, 2024 and Monday, November 4, 2024 from 8:00 a.m. to 5:00 p.m. and November 5, 2024, Election Day at 6:15 a.m. and may not be released until approximately 9:00 p.m. after the vote center closes. Students are responsible for providing their own transportation to training and to their assigned vote center. While we cannot promise that your student will work within close proximity to their school or home, we will try to place your student as nearby as possible. Students are given compensation the same as other Election Officers of \$20.00 per hour and an additional amount of \$60.00 for attending a three hour training session\*. Compensation checks are issued 8 weeks after the election.

The Registrar of Voters has a great demand for Student Election Officers with bilingual skills in **Spanish**, **Tagalog**, **Korean**, **Chinese** (**Cantonese/Mandarin**) and **Vietnamese** languages. Bilingual Student Election Officers assist limited English proficient voters at the vote centers to facilitate effective participation in elections.

In order for your student to be considered for this program, students must complete the attached Nomination Form, meet the requirements and deadline, and obtain signatures from their parents and nominating **Civics, Social Studies** or **Language** teacher. Please send your information via fax, E-mail, or mail to the Registrar of Voters office.

If your student would like to be considered for the Student Election Officer Program for the upcoming **November 5, 2024 General Election**, the Nomination Form must be completed and returned via fax (951) 486-7320, or E-mail to: **Rovpolls@rivco.org**, or mail to the Registrar of Voters office, 2724 Gateway Drive, Riverside, CA 92507. Our deadline for accepting Student Election Officers Nomination Forms for the **November 5, 2024** General Election is **October 21, 2024**. Incomplete Nomination Forms **will be rejected** or returned to the student for completion, if time permits.
